



The first 6 months of EEX Japanese Power Futures


A successful start to a new era

- EEX successfully launched their clearing service for Japanese Power Futures on 18th May 2020
- Despite the challenges caused by the global COVID-19 crisis, a number of market participants from both Japan and overseas were ready on Day 1 and first trades were cleared
- **On behalf of the entire EEX team, we would like to thank all market participants for their support in the 18 months prior to the launch of the Japanese market**
- **This launch would not have been possible without the support and constructive feedback from across the entire value chain**



The first 6 months of EEX Japanese Power Futures

Trade volumes are growing



- Over the six months since our launch in May 2020, traded volumes have reached 329 GWh
 - May: 11.8 GWh
 - Jun: 104.5 GWh
 - Jul: 0.04 GWh
 - Aug: 58.5 GWh
 - Sep: 42.3 GWh
 - Oct: 111.5 GWh

- October saw our highest monthly volume so far

- Trades registered along the entire curve; Weeks, Months, Quarters, Seasons and Years for Tokyo Area Baseload

- As Winter demand season approaches, we expect market activity to increase and more participants to join





Initiatives to further develop liquidity

Zero fees until 30th April 2021

- To support the development of initial liquidity, EEX have extended the trading and clearing fees waiver for Japanese power contracts until 30th April 2021, after which

EEX trade registration fee	0.002 JPY/kWh = 2.00 JPY/MWh
ECC clearing fee	0.001 JPY/kWh = 1.00 JPY/MWh

Note:

- Brokerage (“matching”) fees are payable directly to brokers by the end clients, according to their individual service agreements with them
- Trading and clearing fees will be collected by EEX and ECC through the respective Clearing Members, who will recoup the fees from their clients
